2	Minutes of the previous meeting (held on 5 December 2018): The minutes were accepted as a true record (proposed by DHN, seconded PCD).	
3	Matters Arising: a. Notices of Motion / AGM – AGN put up a notice for members to be aware of how (and when by) they can make a notice of motion for the AGM, as well as emailing all members with the same. No notices of motion have been received from the membership.	
	The committee's notice of motion will be that the members adopt a new team selection policy (see appendix 1). We will put this to the members, and if adopted, they will then also need to vote between the two options therein.

This has now started again for 2019, and is expected to be concluded by the AGM.	

	The Winter Singles Competition was won by Ian Mitchell, who beat Sam Blackstone 11-6 in the final, in a field of 24.	
	AGN has added a list for the member + non-member doubles competition, to be held on 9 March (weather permitting), as well as a schedule of dates of the other competitions. There are only six names down so far, and AGN encouraged the committee to drum up support for the event. AGN also noted that he was likely to be away that weekend, and so PCD and AMF would need to run the event on the day.	All

7	New Membership Applications: AGN stated that when going through SAY's accounts, he noted that several members were able to purchase a part-year, however, those that joined just for the winter had to pay a full year. AGN stated that he understood why this had happened, but proposed that as a gesture of good faith to those that paid full price just for winter, we offer a special re-join price of 50% if they renew by the end of April 2019.	
	A discussion was had around this. AMF said that those that joined all knew what they were paying for, so felt that there was no reason to offer this. A vote was taken, and it was decided not to offer any discount to those members who joined late in 2018, for their 2019 renewal.	
	AGN asked whether £30 was now too low a subscription fee for members, being as we are the only Kendal area club that offers winter bowling. It was felt that whilst it was low for those that played over winter, it would be unfair to ask all members to pay a higher fee, as many didn't use the green over winter.
