Minutes of the committee meeting held on Weds 21st Aug 2019 at 7-30pm

Minutes of previous meeting :- The minutes of the previous meeting, held on Weds 17th July 2019, were read and approved. These were proposed by S.H. & seconded by D.H., all agreed.

This letter, and ALL of its various complaints, were discussed at length by the committee. A response to each & every complaint was agreed upon, and a letter is to be drafted. Once complete, this letter of response will be circulated to all committee members, and the club president, for approval, before being sent to Lesley.
